### OBLIGATIONS AND RESPONSIBILITIES OF THE CLIENT:

**1.STORAGE OF BUGGIES IS AVAILABLE ONLY FOR REGISTERED , FULL MEMBERS OF LIGHTHOUSE GOLF CLUB.**

2.The client agrees to follow the rules and regulation for Buggies on the Golf Course as per **APPENDIX 1 OF THE MEMBERSHIP CONTRACT**. Those are in detail:

- Golf carts may be used by members and guest who has registered at the Pro Shop.
- Use of Golf Carts privately owned by members is allowed only for the owner and his family.
- Golf carts may be operated only by a person who is over the age of sixteen.
- Drivers of golf carts must obey and comply with all golf cart traffic signs. Two persons and two sets of golf clubs only are permitted on each golf cart.
- Golf cart paths must be strictly followed and adhered to where provided.
- Golf carts must not be driven sixteen thirty feet (twenty meters) of a green, a tee or a bunker, except on golf cart paths. Drivers must never drive a golf cart through a hazard, the native areas or in a way which may cause harm or endanger the safety of the driver, the nature and of others.
- Drivers must avoid soft areas on fairways, especially after rain and in wet conditions. Drivers must use the semi rough whenever possible.

- Posted golf cart signs must be strictly adhered to and followed without exception.
- Golf carts may be operated at the golf course only when the golf course is open for play and the use of Golf Carts is expressly allowed.

The client ensures that he/she is aware of all terms and conditions of Buggy use, as well as of the areas where the usage of the Buggy is not allowed.

**IN CASE OF FAILURE TO FOLLOW THOSE RULES ON THE PREMISES OF THE RESORT THE CLIENT MIGHT BE ASKED TO DISCONTINUE THE USE OF THE BUGGY ON THE PREMISES OF LIGHTHOUSE GOLF CLUB.**

3. The client agrees to indemnify Lighthouse Golf Club against all claims, costs and demands made against Lighthouse Golf Club arising out or about the use of the Buggy on the premises of the Resort.
4. If damage to the Buggy or to third parties through this Buggy occur while in use of the client, the client is solely liable for all damages caused by his/her Buggy. Lighthouse Golf Club is not responsible for any damages on the Buggy/caused by the Buggy.
5. The client is responsible and liable to any damages due to amortization, force major and circumstances or powers out of the control of the Golf Club.
6. **THE CLIENT IS RESPONSIBLE FOR AND MUST COVER ANY MAINTENANCE AND/OR CLEANING COSTS FOR THE BUGGY THAT OCCUR DURING THE NORMAL OPERATION (CHANGE AND REPAIR OF TIRES, BATTERIES, BRAKES ETC.).**  
**ANY MAINTENANCE AND/OR CLEANING WORK ON THE BUGGY IS NOT PART OF THIS CONTRACT AND MAYBE OFFERED BY THE GOLF CLUB FOLLOWING AN OFFER THAT WILL BE AVAILABLE FROM THE PROSHOP.**
7. **DURING THE WINTER SEASON, NO BUGGY WILL BE ALLOWED TO BE STORE IN THE MAIN ENTRANCE OF THE BUILDINGS – THE OWNER OF THE BUGGY WILL HAVE THE CHOICE BETWEEN PURCHASING A WINTER STORAGE AT LIGHTHOUSE OR TO STORE HIS BUGGY ON HIS OWN PLACE.**
8. **THE USAGE OF THE BUGGY ON THE PREMISES OF LIGHTHOUSE GOLF CLUB IS ALLOWED SOLELY FOR THE USAGE OF THE OWNER AND HIS/HER FAMILY. IN CASE LETTING THE BUGGY TO A THIRD PARTY, THAT IS NOT MEMBER OF THE FAMILY OF THE OWNER, THE OWNER WILL BE ASKED TO DISCONTINUE THE USE OF THE BUGGY ON THE PREMISES OF LIGHTHOUSE GOLF CLUB AND PAY A FEE.**

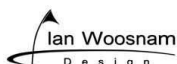
